FEDERAL CANDIDATES (PRESIDENT, US SENATE, US HOUSE OF REPRESENTAVIES)

FEDERAL ELECTION COMMISSION (FEC)

The Federal Election Commission (FEC) oversees campaign finance reporting for federal candidates, including President and Members of Congress.

RESEARCHING CAMPAIGN FINANCE REPORTS

1. Open up the FEC's website in a web browser, www.fec.gov.
2. Click on the Campaign Finance Data tab and then click All Data>>.



3. On the Campaign Finance Data page you can search either by candidate/committee or by specific individual (search by candidate/committee if you want to see how a campaign is raising and spending money; search by individual contributor if you want to see to whom a particular person is giving money).
4. As you are typing a name in the candidate search box, start with the last name. The webpage will begin to offer suggestions. Be sure to click on the candidate you're looking for, not one of the committees, as there may be many per each candidate. Click on the suggested name, or click the magnifying glass icon after you have typed in the name.
5. On the Financial Summary screen, choose the election year cycle you're researching (it will default to the current year).
6. To see what individuals have contributed to the candidate, click on the dollar amount listed beside *Itemized Individual Contributions*.

TEXAS ETHICS COMMISSION (TEC)

The Texas Ethics Commission (TEC) oversees campaign finance reporting for state and district candidates and officeholders, including statewide offices (Governor, Lt. Governor, Attorney General, Supreme Court, etc.), state legislature (House of Representatives and State Senate), State Board of Education, Courts of Appeal, and District Judges.

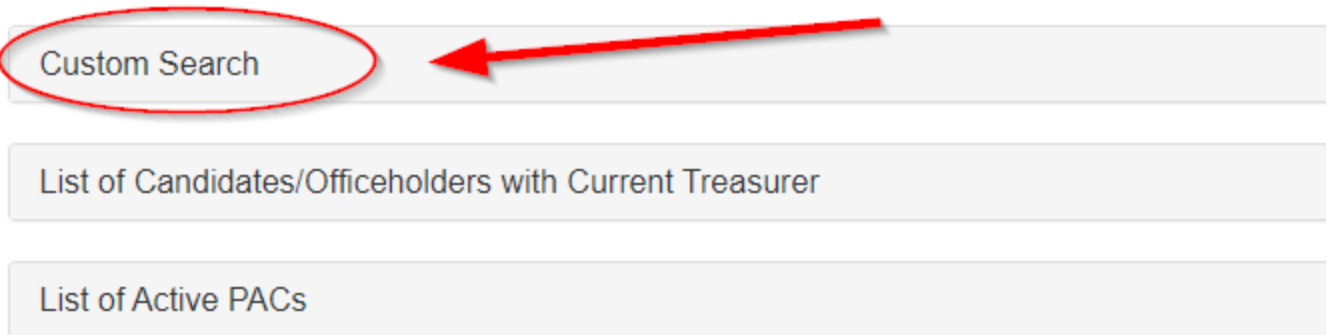

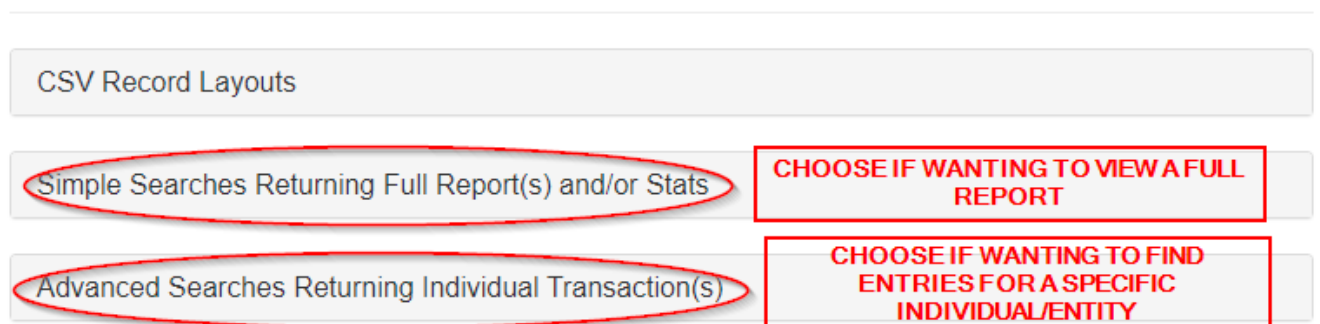

6. **ADVANCED SEARCH:** After you click Advanced Search and arrive at the Advanced Search page, you will have to choose some options in order for the name search field to appear.
 - a. For the Transaction Type drop-down menu, you will need to choose if you want to search for contributions made to a campaign or expenditures made by a campaign.
 - b. For Search Type, choose By Name on Transaction.
 - c. For Date Type, you will need to choose whether you want to search transactions in a specific year, or over a date range.
 - d. Once you choose a date type, you will need to choose the Year or the Date Range.

- e. At this point you should now be presented with the option to enter an Entity/Last Name and First Name search fields.

Advanced Search

You must enable POP UPs in your browser settings to obtain your search results!

Due to the increased volume of contribution and expenditure data, all searches based on filer identification data are performed using Filer ID rather than using can get the Filer ID by using Simple Search.

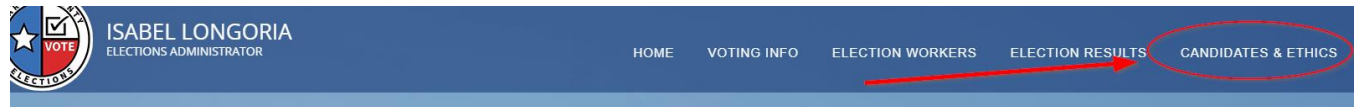

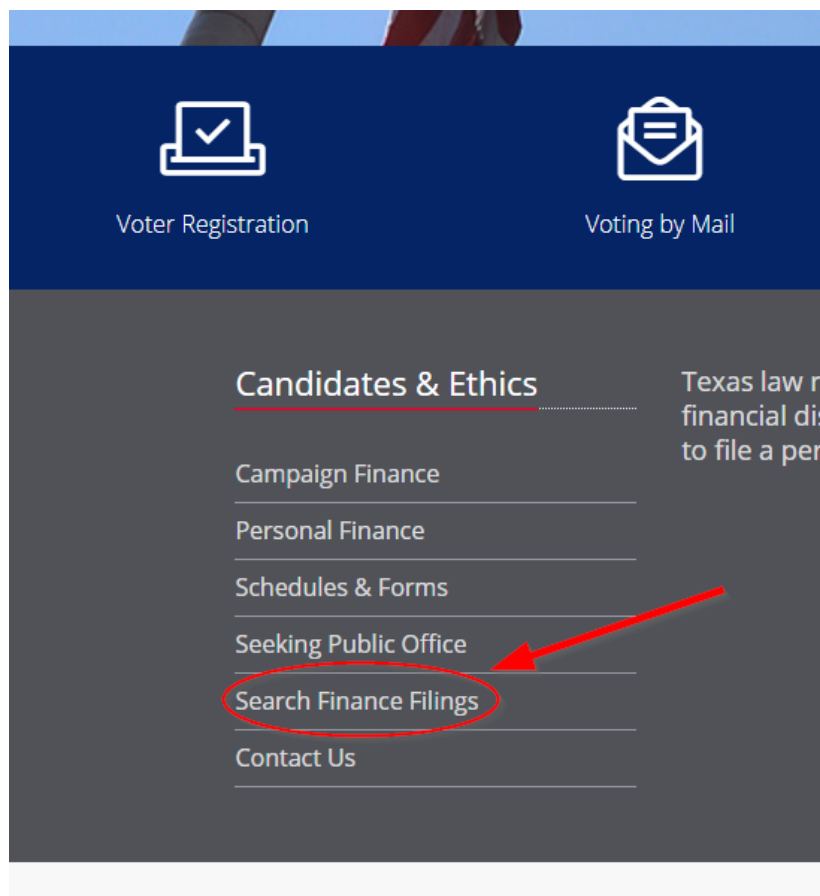

It is the policy of the Harris County Commissioners Court to encourage open government. In keeping with this policy, you can view Contribution and Expenditure Reports for various county offices, Conflict of Interest Filings, Voluntary Registration of Lobbyists and Personal Financial Disclosure for certain county officials.

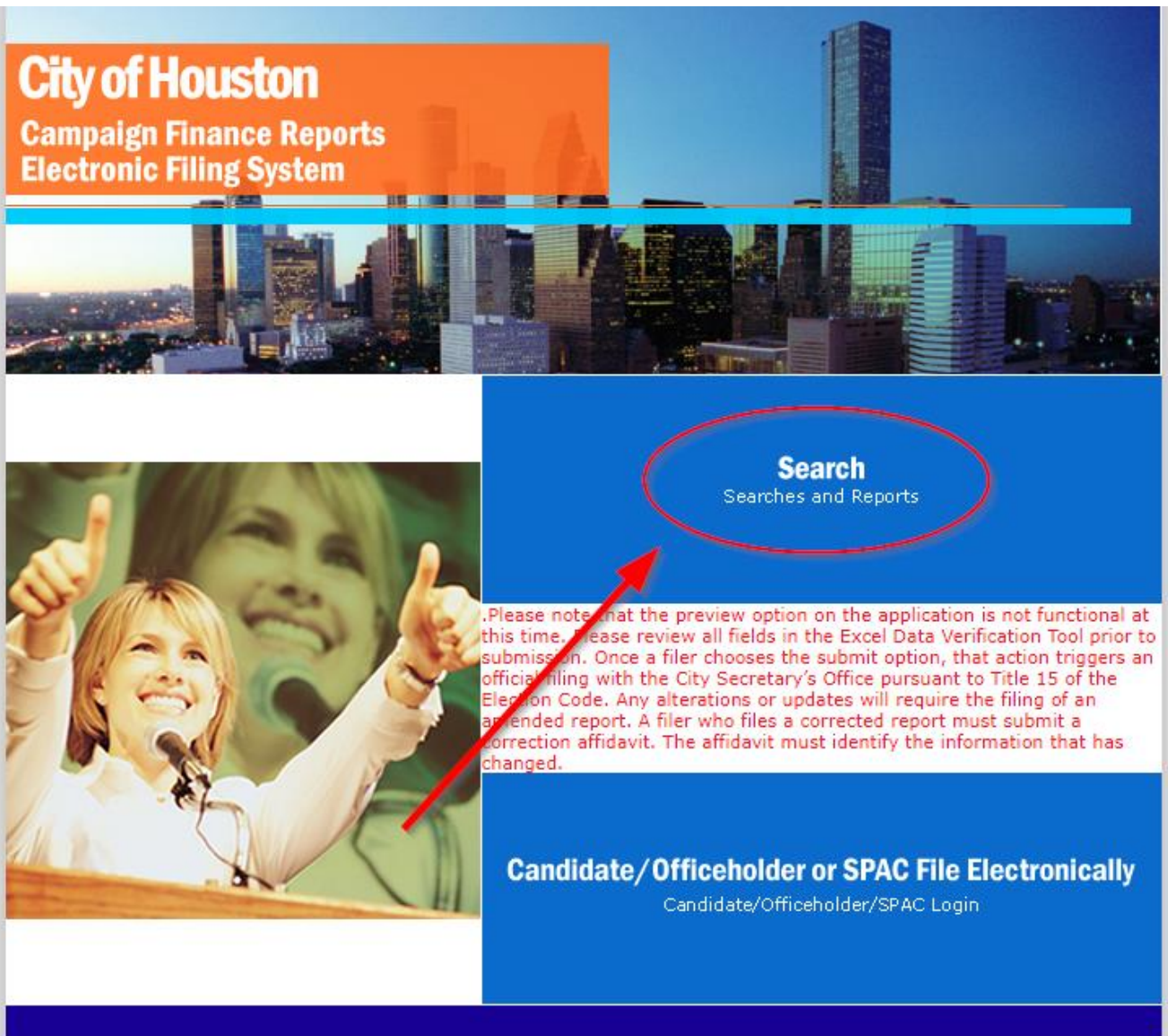
CITY OF HOUSTON CANDIDATES (MAYOR, CONTROLLER, COUNCIL MEMBERS)

CITY OF HOUSTON CAMPAIGN FINANCE WEBSITE

Campaign finance reports for city candidates and officeholders are maintained by the City of Houston (City Secretary). The system, unfortunately, is a bit clunky and not nearly as easy to use as the previous reporting systems.

RESEARCHING CAMPAIGN FINANCE REPORTS (FILED ELECTRONICALLY)

1. Open up the City of Houston’s Campaign Finance Reports Electronic Filing System website in a web browser, <https://cohweb.houstontx.gov/CampaignFinanceWeb/>
2. Click on the box that says Search.



3. Click on the Advanced Search for Campaign Finance Reports button.

The City Secretary has two business days to post reports from the date of filing.

This system went online on July 1, 2007. Any reports filed non-electronically are viewable in PDF format here:

4. First you will need to choose the year of the report you want to view.
5. Choose whether you want to view the report of a candidate/officeholder, a PAC, or both.
6. You can choose whether to retrieve the results as a webpage (PDF) or as an Excel file.
7. Enter the Last Name/Entity Name and First Name of the person or organization you're researching. You may want to only enter a last name to keep the results from being too narrow.
8. Click Search.

CITY COUNCIL

Campaign Finance Reports (Historic)

Reports for City of Houston election years (odd numbered years) are due to the City Secretary on January 15 (Period I), July 15 (Period II), 30 days before the election (Period III), and 30 days before the runoff election (Period IV). Certain positions will have a runoff, eight days before the runoff election (Period V). Period V also covers candidates who did not win their races in the general election.

In even numbered years, reports are due January 15 and July 15 of the year following the election. Reports are due for former candidates who still have campaign debt, and PACs. Read [Reports Online](#).

The City Secretary is required by Section 254.040, Election Code, to make reports available to the public within two (2) years after the date each report is filed.

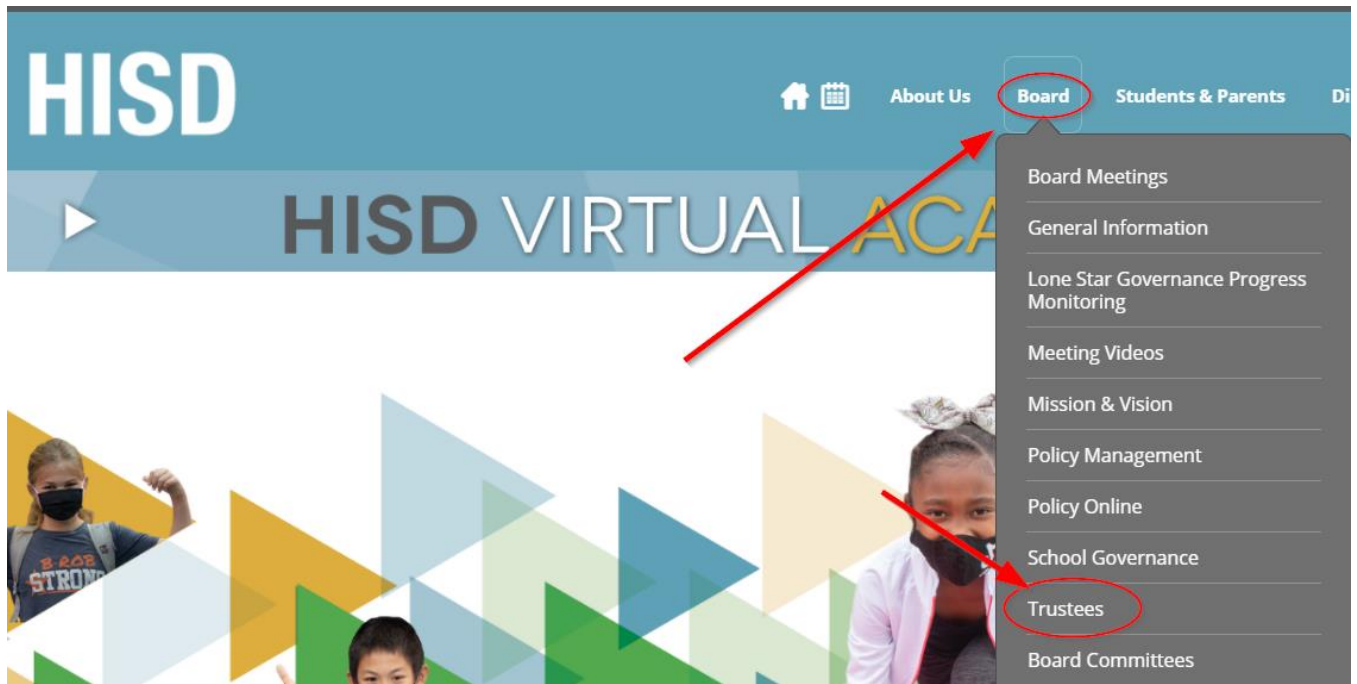

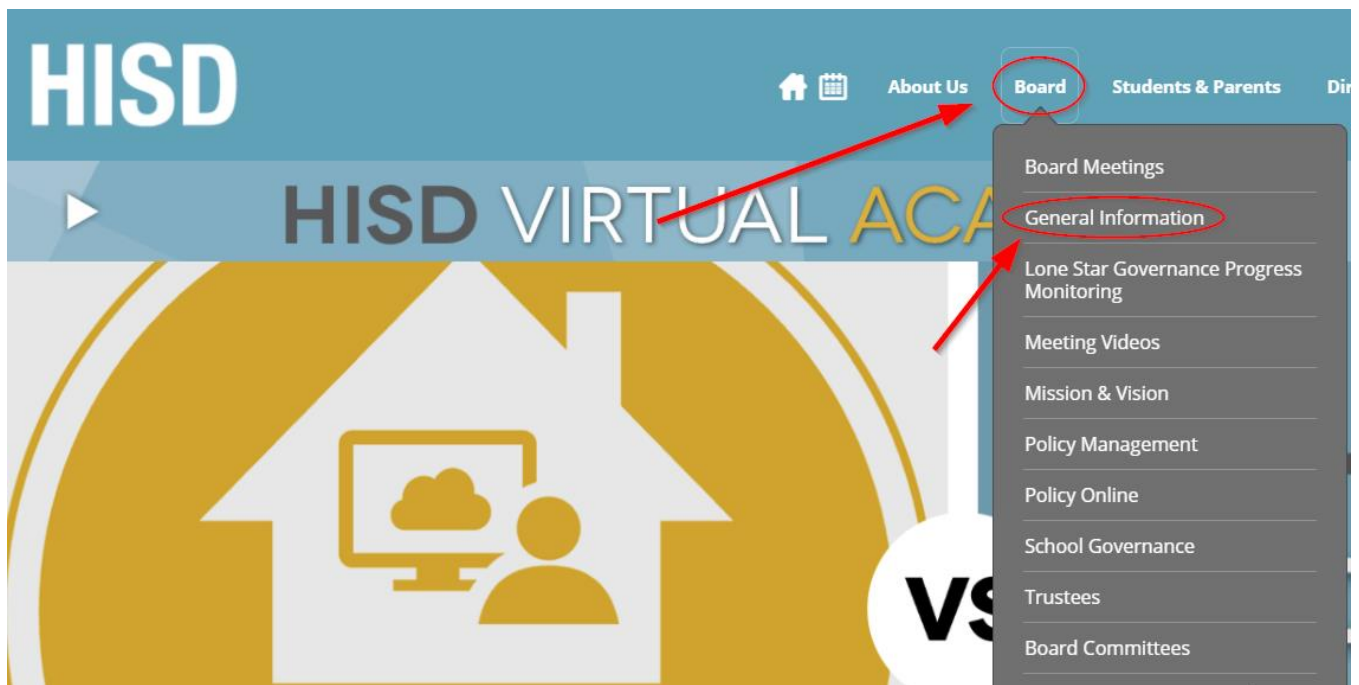

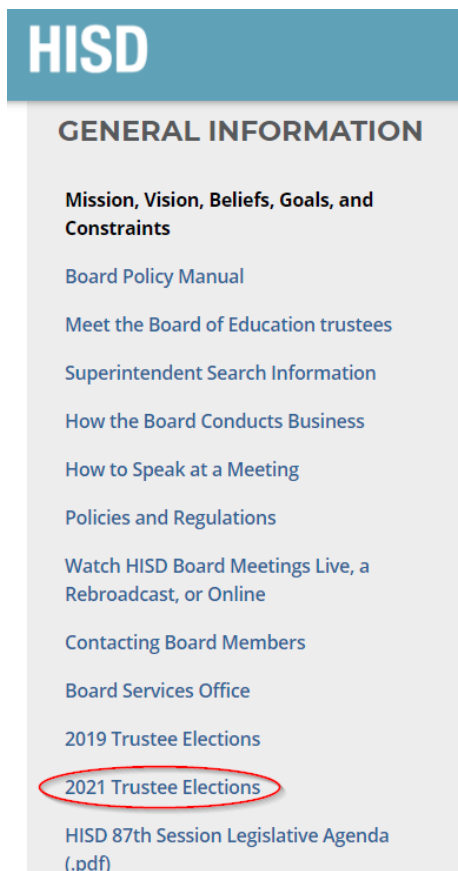

“At Transparency USA, our mission is to provide clear, accurate, easy-to-understand information about the money in state politics.

Our database includes campaign finance data for nine states: Arizona, Florida, Michigan, Minnesota, North Carolina, Ohio, Pennsylvania, Texas, and Wisconsin. You can search all state-level candidates, political action committees (PACs) that are active in that state, and the donors that support them. Texas is our first state to also include lobbying data.

State-level politicians include your governor, state attorney general, and legislators who serve in your state House of Representatives and state Senate. If they serve in your state capitol, you'll find detailed data on their contributions and expenditures here. You won't yet find federal candidates, which include the president, members of the U.S. Congress, and most politicians working in Washington, D.C. We look forward to adding federal data soon.

You can see big-picture data, like the top 10 donors in your state this election cycle or total contributions and expenditures by party. You can also find detailed transaction history for a single person or organization.”

“LittleSis is a free database detailing the connections between powerful people and organizations. We bring transparency to influential social networks by tracking the key relationships of politicians, business leaders, lobbyists, financiers, and their affiliated institutions. We help answer questions such as:

- Who do the wealthiest Americans donate their money to?
- Where did White House officials work before they were appointed?
- Which lobbyists are married to politicians, and who do they lobby for?

All of this information is public, but scattered. We bring it together in one place. Our data derives from government filings, news articles, and other reputable sources. Some data sets are updated automatically; the rest is filled in by our user community.”
